The ornamental design for a kinetic sculpture, as shown and described.

DESCRIPTION

FIG. 4 is a top view of the invention shown in FIG. 1.

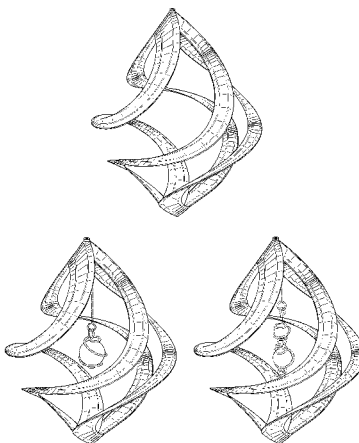

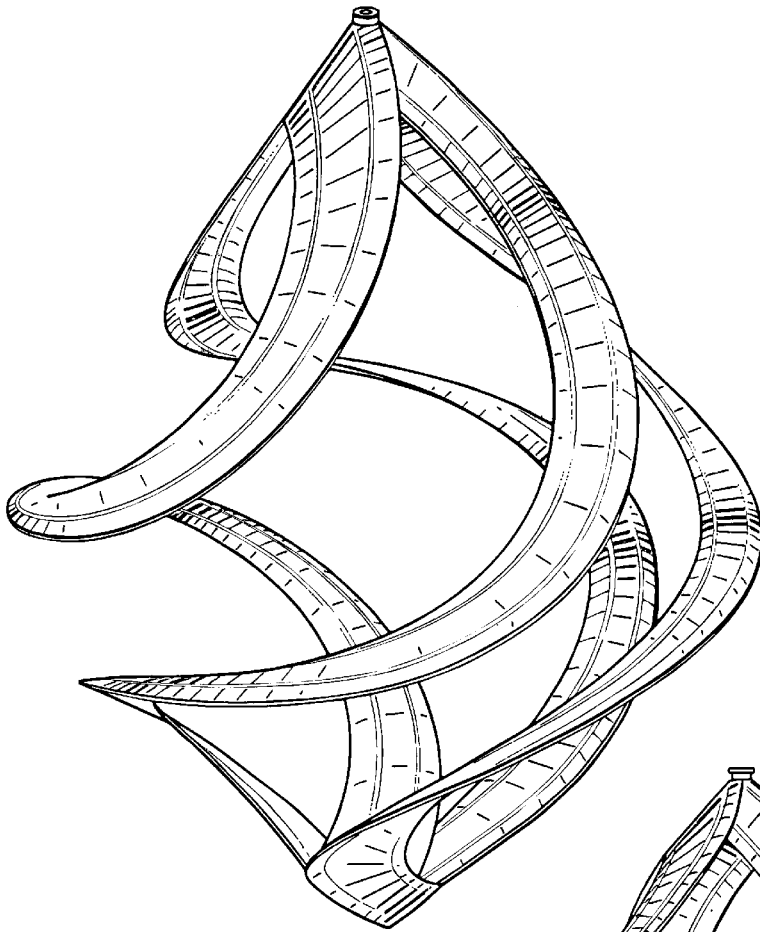

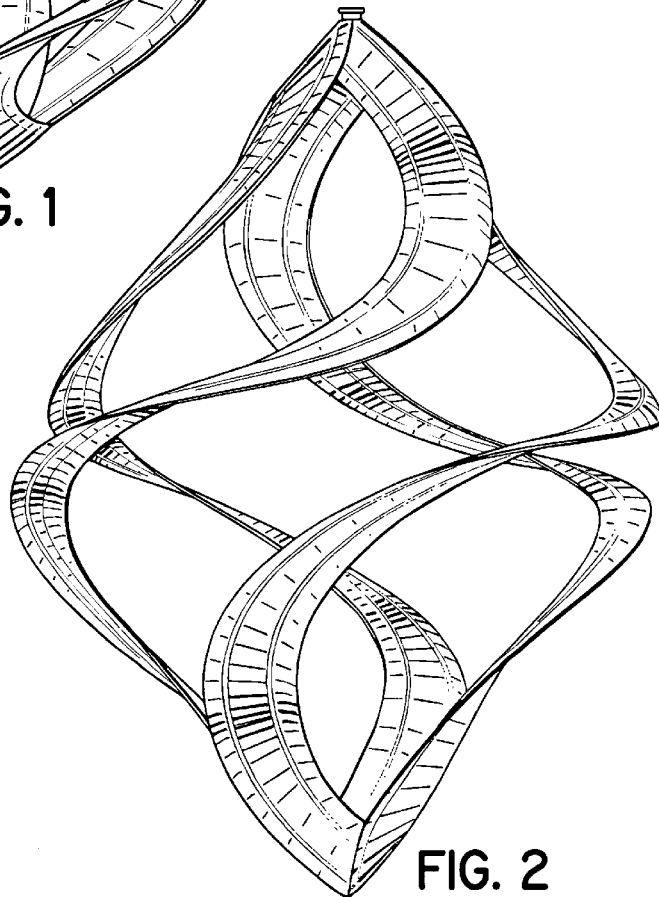

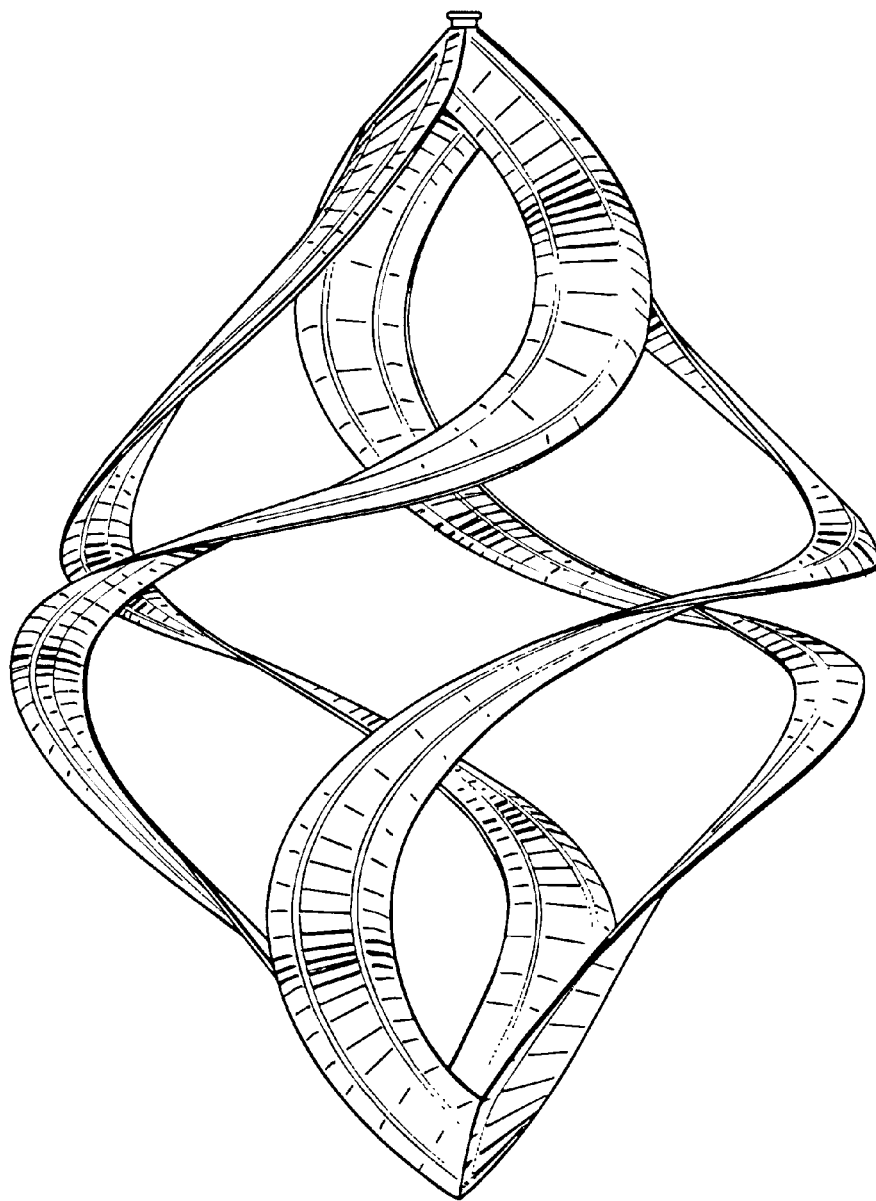

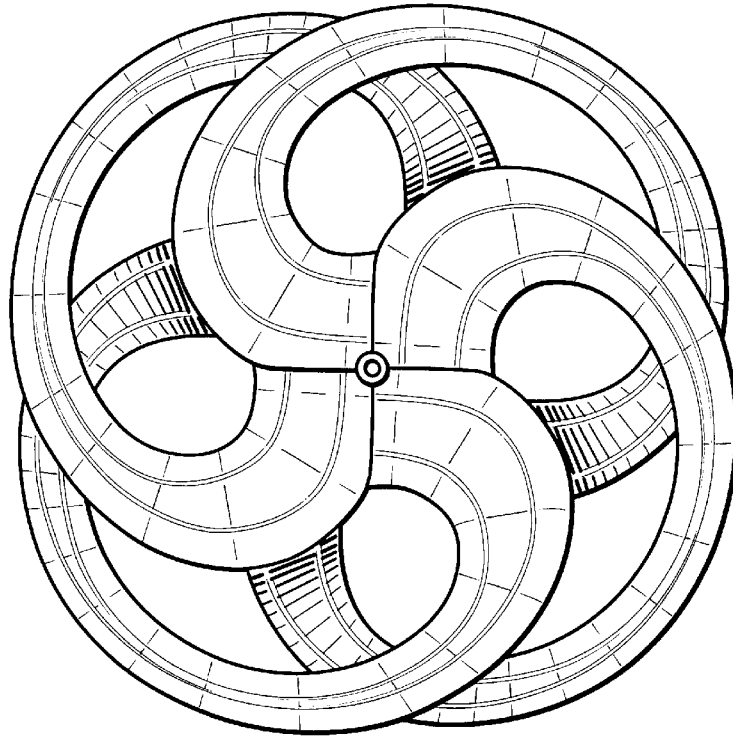

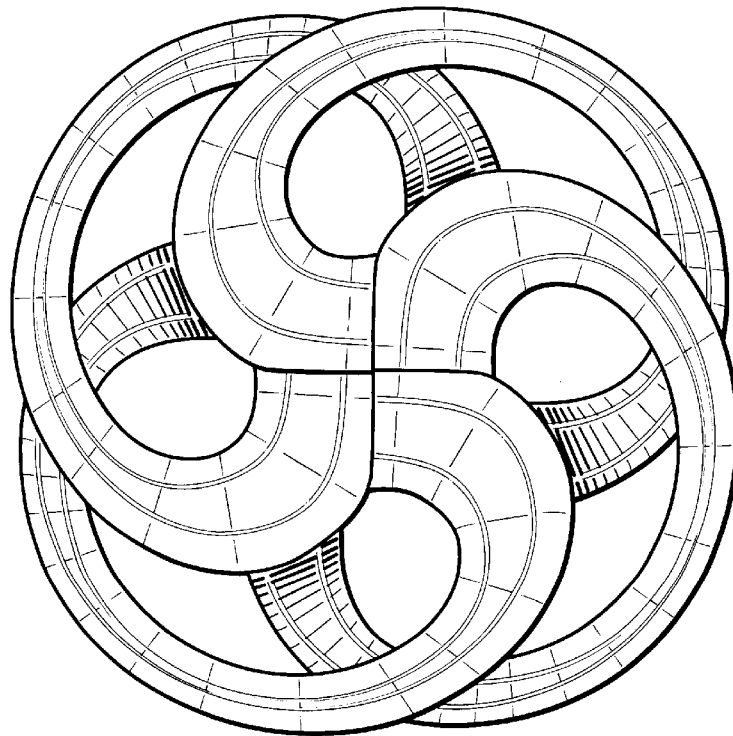

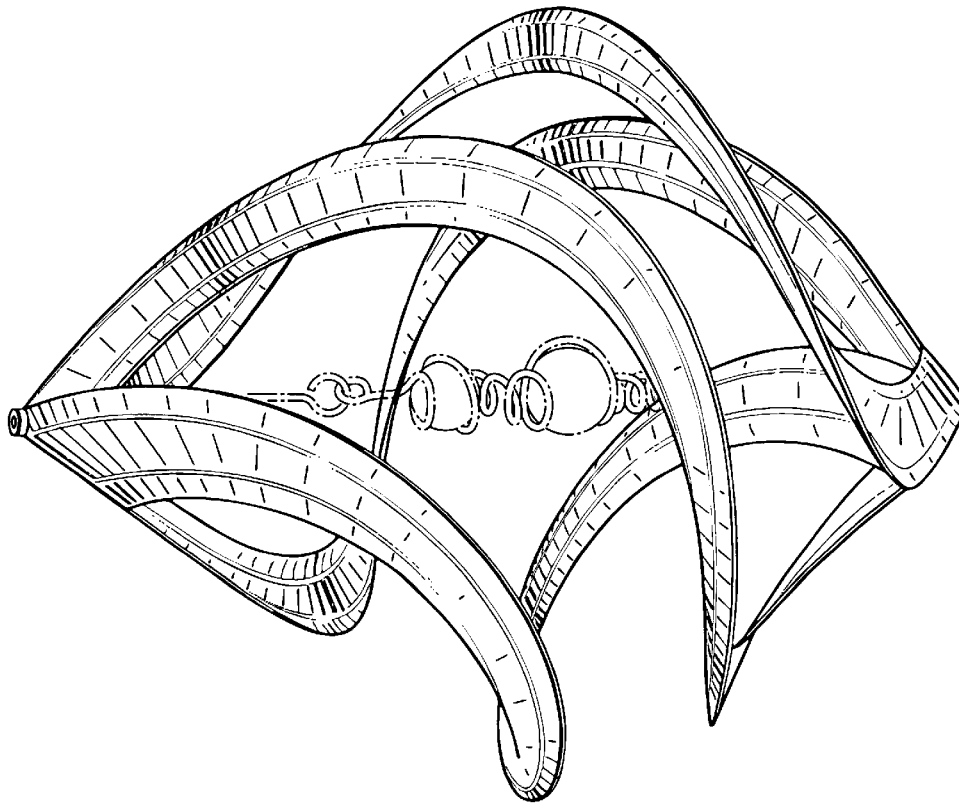

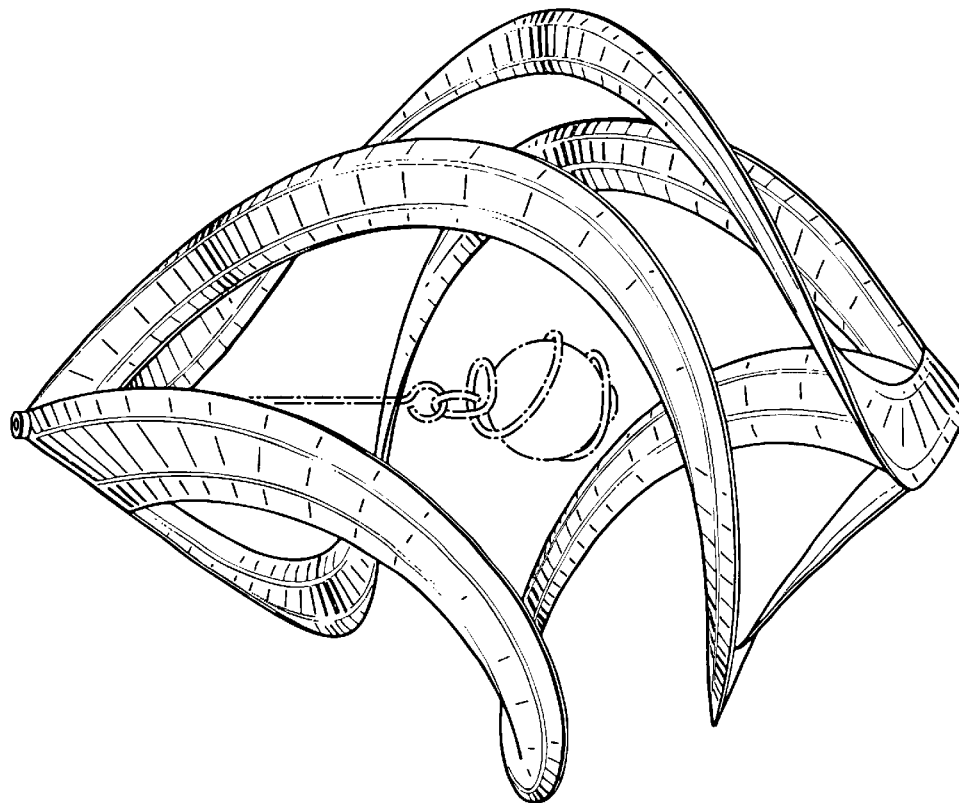

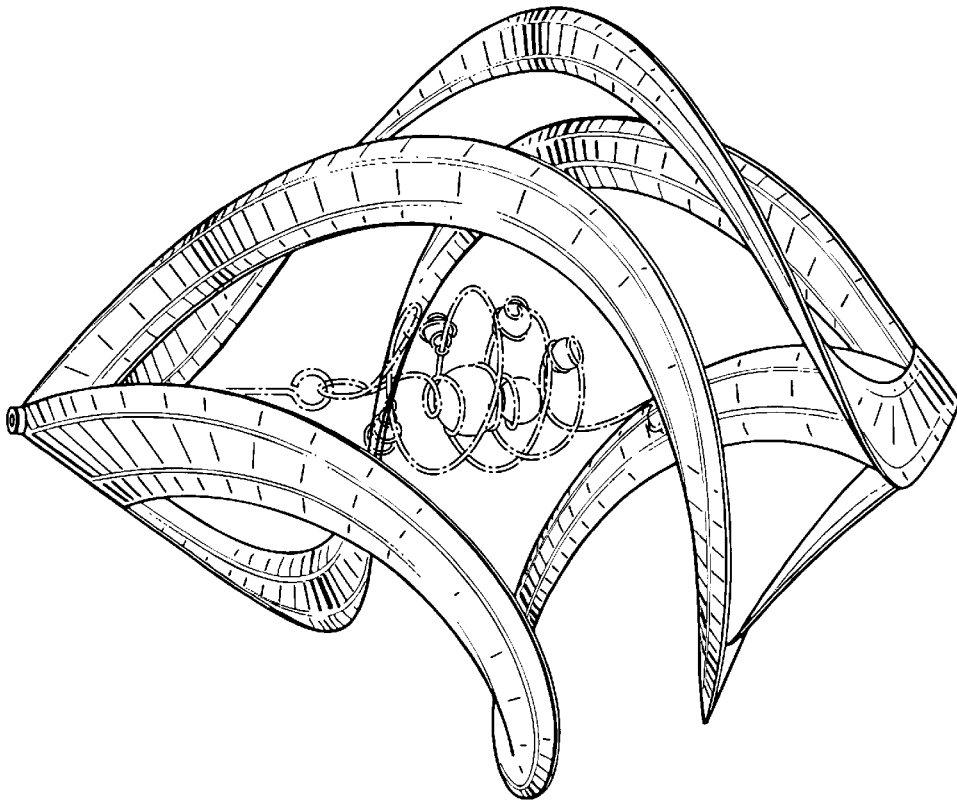

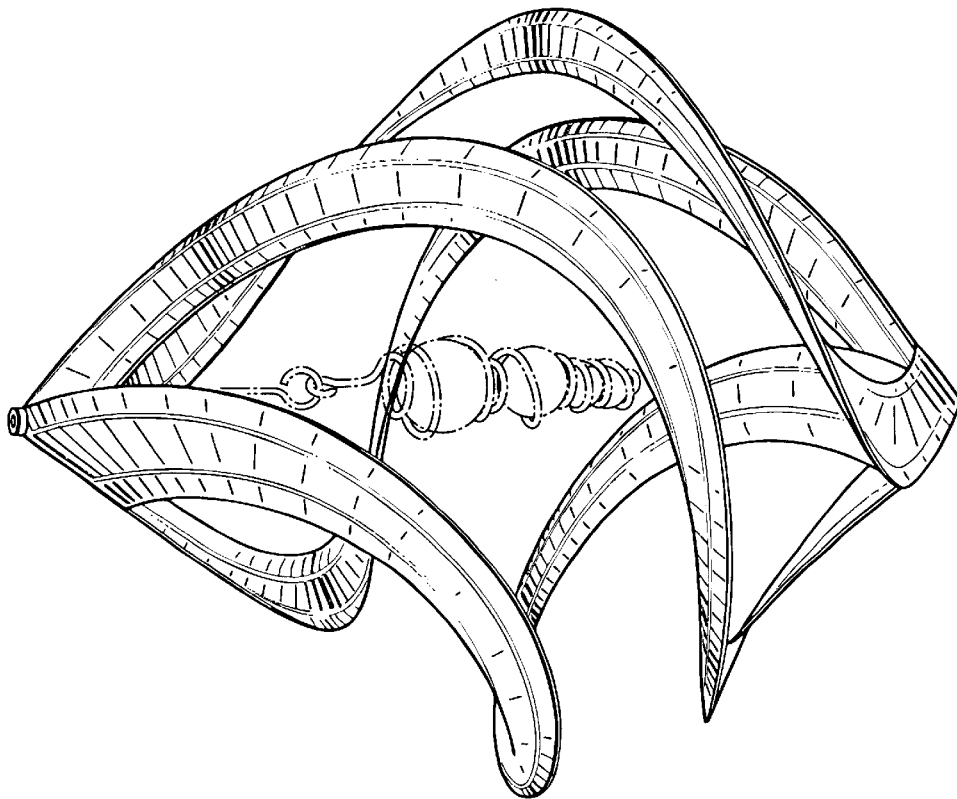
